You are about to purchase a product that is not simple and may be difficult to understand.

#### What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. The product is primarily aimed at investors who expect a decreasing volatility of the Underlying and that the value of the Underlying will be at the same level or above the Cap Level at maturity of the product. The product has a fixed term and matures on the Redemption Date.

Repayment of the product is dependent on the performance of the Underlying on the Final Fixing Date. The repayment terms are as follows:

- If the Final Fixing Value of the Underlying is at or above the Cap/Cap Level: the product is repaid in the amount of the Denomination; or

If the Final Fixing Value of the Underlying is at of above the Cap/Cap Level: the product is repaid at an amount equal to the Denomination multiplied by the Final Fixing Value of the Underlying divided by the Cap Level, i.e. the redemption amount is linked to the negative performance of the Underlying. In such a case, the investor suffers a loss if the redemption amount is lower than the amount he invested.
