However, if the Final Fixing Value of the Underlying is below the Cap Level, the investor receives a cash repayment corresponding to the Denomination divided by the Cap Level and multiplied by the Final Fixing Value. Therefore, the investor may suffer a partial or total loss. The acquisition price is 98.00% of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying.

Modifications
