**Key elements of the product**

The ZKB Discount Certificate is an investment instrument that combines the purchase of an Underlying with the simultaneous sale of a call option. This allows the investor to benefit from the current volatility of the Underlying. An above-average return is achieved when prices stagnate or rise slightly. If the Final Fixing Value of the Underlying is at or above the Cap Level, the investor receives a cash redemption in the amount of the Denomination. If the Final Fixing Value of the Underlying is below the Cap Level, the investor receives a cash redemption in the amount of the Denomination multiplied by the Final Fixing Value and divided by the Cap Level. However, the cost price achieved in this way is lower than the price of the Underlying at the time of issue.

**Tax aspects Switzerland**

Any return on the product qualifies as capital gain and is generally not subject to Swiss income tax for private investors with Swiss tax domicile. The Federal securities transfer stamp tax is not levied on secondary market transactions. The product may be subject to further withholding taxes or duties, in particular under the rules of FATCA or Sect. 871(m) U.S. Tax Code or foreign financial transaction taxes. All payments from this product are made after deduction of any withholding taxes and levies.
