If a Knock-in Event occurs, the investor will receive a physical delivery of a number of Underlyings as defined in Ratio of the Underlying having the largest negative performance. Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 100.00% of the Initial Fixing Value (Cap Level). This negative performance is reduced by the guaranteed Coupons paid out during the term. and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this product.

Specific product risks
