Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 92.00% of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying.

Issuer Risk

Specific product risks
