The acquisition price of the delivered Underlyings is 85.00% of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying.

Issuer Risk

Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. Specific product risks
