However, the cost price achieved in this way is lower than the price of the Underlying at the time of issue.

Therefore, the investor may suffer a partial or total loss. The acquisition price is 85.00% of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying.
