The interest payment is subject to income tax at the time of payment. The Swiss withholding tax is not levied. Therefore, the investor may suffer a partial or total loss. 3. Material Risks for Investors

Issuer Risk

Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer.
