The interest payment is subject to income tax at the time of payment. The Swiss withholding tax is not levied. Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 90.00% of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying. 3. Material Risks for Investors

Issuer Risk
