However, if the Final Fixing Value of the Underlying is below the Cap Level, the investor will receive a physical delivery of a number of Underlyings as defined in Ratio. Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 93.86% of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying.

Modifications
