Therefore, the investor may suffer a partial or total loss. This negative performance is reduced by the guaranteed Coupons paid out during the term.

3. Material Risks for Investors

Issuer Risk

Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer.
