The Coupon of 18.0954% p.a. is divided into a premium payment of 18.0954% p.a. and an interest payment of 0.00% p.a.. The interest payment is subject to income tax at the time of payment. The Swiss withholding tax is not levied. If a Knock-in Event occurs and if the Final Fixing Value of the Underlying is below the Cap Level, the investor receives a cash repayment corresponding to the Denomination divided by the Cap Level and multiplied by the Final Fixing Value. Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. Specific product risks
