If the Final Fixing Value of the Underlying is below the Cap Level, the Underlying is delivered. The number of Underlyings is defined in Ratio (fractions will be paid in cash, no cumulation). However, the cost price achieved in this way is lower than the price of the Underlying at the time of issue.
